Project Description: The intent of the Rose Master Plan was to provide a framework through

which all facets of the project could be developed with cohesive architectural and infrastructure components. The project proponent, Edward Rose & Sons (Edward Rose), has been working diligently over the past several years on detailed environmental, traffic, planning and market analysis related to its Master Plan development. This analysis resulted in some proposed revisions to the Master Plan to reduce environmental impacts, improve traffic operations, and result in a more

successful master planned community.

While in the process of pursuing a Master Plan Amendment to address these revisions, it became evident that any future changes to the site plan could trigger additional Master Plan Amendments. In an effort to streamline the approval process, Edward Rose determined that the most clear and predictable path forward would be to release the Master Plan, extinguish the Development Agreement and remove the Master Plan Overlay from the City of Poulsbo Zoning Map and propose a new project under current Poulsbo Municipal Code and development

standards.
